NATIONALITY OF MEMBERS: As explained many times previously, this information is not accurately reflected in the files of this lodge nor is it something that can or should be asked when new petitions are received. It is strongly recommended that you eliminate this section from the Annual Report.

LOST DURING THE YEAR: I have checked my records numerous times but end up with the same problem. I started this year with 154 members on the rolls. I end up with exactly 147 but cannot explain the loss of one additional member over and above the 2 Demits, 1 Suspension for NPD, 3 Suspension—Other (INACTIVE LIFE MEMBERS), and the 5 Deaths. If the error can be located please advise.

TOTAL DUES AND FEES REMITTED WITH THIS REPORT:

The Dues for 147 M.M. on December 31st, 2000 equals Y367,500 For 1 Initiation/Passing/Raising (Bro. Nakanishi) equals Y 3,000 For a Grand total of Y370,500

However, the following <u>OVER/UNDER PAYMENTS</u> were made to Grand Lodge at the end of 1999:

- 1) Annual Dues and Fees were paid for Brothers Harold Almont HORNER and John William HOPKINS for the years 1996 through 1999. Both of these Brethren died in 1996 but was not reported until 2000. This results in an OVERPAYMENT to Grand Lodge of Y20,000 total.
- 2) Annual Dues and Fees were not paid for Brothers Tomas Lee BRACK, Edward HAKALA, and Alexander V.S.C. SHAW for the years 1996/1997/1998 and 1999 for all three Brethren. This results in an UNDERPAYMENT to Grand Lodge in the amount of Y30,000 total.

The additional Y10,000 due Grand Lodge has been added to the <u>TOTAL DUES AND FEES</u> REMITTED WITH <u>THIS REPORT</u> for a TOTAL of Y380,500.

THIS LISTING WILL BE APPENDED TO AND WILL BECOME A PART OF THE "ANNUAL REPORT" REQUIRED TO BE SUBMITTED TO GRAND LODGE. THIS LISTING IS FILED, TOGETHER WITH A SUITABLE COVER LETTER, UNDER FILE 1-36.

AN ATTEMPT WILL BE MADE ANNUALLY TO LOCATE THESE BRETHREN USING WHAT EVER MEANS MAY BE AVAILABLE. IF FOUND STILL ALIVE, THE BROTHER IS TO BE RETURNED TO THE ACTIVE ROLLS, HIS NAME REPORTED TO GRAND LODGE AND HIS BACK GRAND LODGE DUES PAID TO GRAND LODGE.
